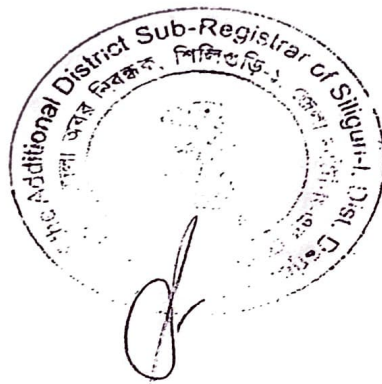

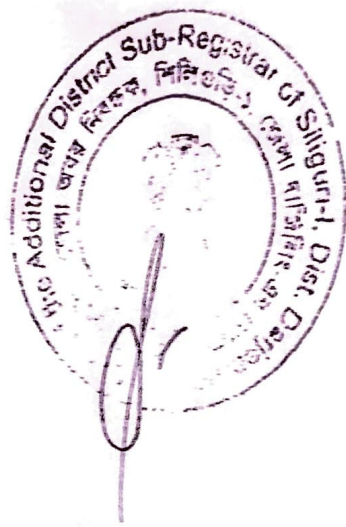

- (b) The abovenamed persons have agreed to become Trustees and to hold and apply the said sum of Rs.1,00,000.00 only and all gifts, contributions, subscriptions and donations for the said Trust to be received, for public charitable purpose and subject to a Trust power and norms contained in the Trust Deed. That at the time of registration the Trust holds only this Rs.1,00,000.00 only as all its assets and all other gifts, contributions, subscriptions, consisting of movable and immovable properties will be accepted after registration of the Deed of Trust.

In order to effectuate the said desire the Settlers together with MISS SALONI PRACHI have made over to the Trust a sum of Rs.1,00,000.00 only to hold the same together with all other properties that may be acquired after registration of a Deed of Trust out of the same or otherwise and may hereinafter referred to as the 'Trust Fund' for the objects and purposes hereinafter expressed with the power and on the terms and conditions contained in this Deed.

- (c) In the above backdrop, the abovenamed Settlers namely viz. SMT. SONIA PRASAD, SRI RAJ KUMAR PRASAD, MISS SHAILJA PRACHI, together with MISS SALONI PRACHI have formed the trust under the name and style of 'SUSHILA EDUCATIONAL FOUNDATION' having its office at 16, Bye Lane, Nivedita Road, Pradhan Nagar, Post Office and Police Station – Pradhan Nagar, Siliguri, Pin – 734 003, District – Darjeeling, in the State of West Bengal and the said trust have started its functioning on & from the 1st day of the month of March, 2018.

(d) In order to proper functioning of the trust, a deed of trust was prepared and the same was executed by the abovenamed Settlers along with MISS SALONI PRACHI. The said deed of trust was registered with the office of the Additional District Sub-Registrar, Siliguri on 08.03.2018 and the said document was recorded in book No. IV, Volume No. 402 of 2018 at pages from 3574 to 3601 being No. 141 for the year 2018.

(e) After registration of the said deed of trust, the abovenamed Settlers as well as Trustees of 'SUSHILA EDUCATIONAL FOUNDATION' have established and started running a school in the name of 'HARDY RAMANUJAN PUBLIC SCHOOL' at Patharghata, Salbari, Post Office - New Chamta, Police Station - Matigara, Pin - 734 009, District - Darjeeling, in the State of West Bengal, on and from 2nd April, 2018.

AND WHEREAS, in view of Clause No. 10, sub-clause (IX) of the deed of trust being No. IV-141 of 2018, the abovenamed Settlers as well as trustees for the purpose of smooth running and functioning of the educational institution and to fulfill the objects of the trust are desirous to appoint SRI TRIBHUWAN SINGH, son of Late Jaikrishna Singh, SRI SAILESH KUMAR, son of Late Vijay Kumar Prasad, SMT. DURGESH NANDINI, wife of Ranjit Kumar as trustee of 'SUSHILA EDUCATIONAL FOUNDATION'. Accordingly, in a meeting of Board of Trustees of 'SUSHILA EDUCATIONAL FOUNDATION' dated 01.10.2021, it has been resolved unanimously that the above named three persons namely SRI TRIBHUWAN SINGH, SRI SAILESH KUMAR, SMT. DURGESH NANDINI, have been appointed as the trustee of 'SUSHILA EDUCATIONAL FOUNDATION' who will act according to the objects, rules and regulations of the trust.

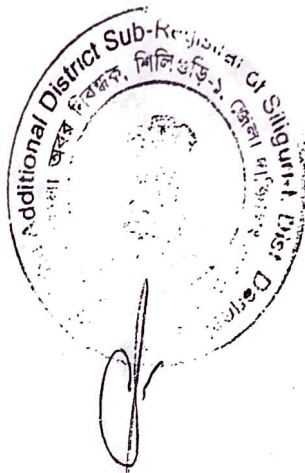

- (b) To establish, support, acquire and run Primary, Secondary and Higher Secondary Schools and Colleges under the Trust 'SUSHILA EDUCATIONAL FOUNDATION' in various parts of India and abroad, with purpose of spreading education in general mass, and to apply for registration/ recognition/ affiliation to any Govt., Semi-Govt. or Private authority or Council or Board or Body which may be compulsory or beneficial for funning the institutions.
- (c) To establish support, acquire and run academic, management, technical, engineering, architecture, vocational and/ or professional training institutions in various parts of India and abroad, generally for the development, advancement of education and diffusion of knowledge amongst the public in general.
- (d) To apply for registration/ recognition/ affiliation to any Govt., Semi-Govt. or Private authority or Council or Board or Body which may be compulsory or beneficial for funning the institutions.

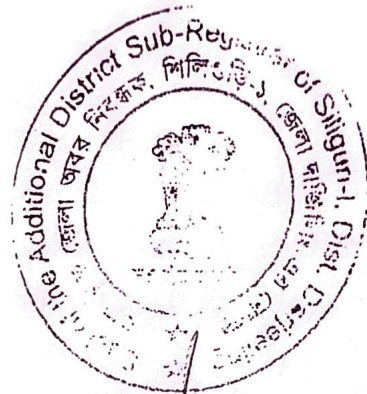

- (e) To grant aid and other financial assistance to schools, colleges, libraries, computer centers, reading rooms, hostels, boarding house, laboratories and other institutions of like nature at any place or places in India or abroad for the use of Students and the Staff and also generally for the development, advancement of education (academic, computer, technical, vocational, cultural etc.) and diffusion of knowledge amongst the public in general.
- (f) To establish, maintain and/ or run studentship, scholarship and render other kinds of aid to individuals including supply of medicines, books, stipends, medals and other incentives to supply without any distinction of caste, colour or creed.
- (g) To charge tuition and other fees from the students and otherwise recoup themselves for the outlay and expenses incurred in the upkeep, maintenance and development of institution to be established by the Trust.
- (h) To establish and/ or grant aid for the establishment and maintenance of Hospitals, Family Planning Centers, Dispensaries, Dharmashala, Gosala, parks and gardens, gymnasiums, sports/ cultural institutions, tube-wells, wells and water works for supply of drinking water.
- (i) To establish, maintain and grant aid to homes for orphans, handicapped and old age people, or other establishment for relief and help to the needy, the poor and destitute people, orphans and widows without any distinction of caste, creed and colour.
- (j) To give, provide and/ or render monetary and/ or other help and assistance for the relief of persons, animals, affected by natural calamities such as flood, fire, famine, cyclone, earthquake, storm, accident, drought, epidemic and the like to give donations, subscriptions

or contribution to institutions, establishment, centre's or persons doing relief work on such occasions.

- (k) To motivate and make people ware and conscious about better provision of health and education for weaker section of the society and to educate people to be aware of dreadful diseases like, Cancer, Aids, Tuberculosis, Polio, Hepatitis B, Leprosy, Drug addiction etc.
- (l) To provide vocational training to mentally and physically handicapped persons in order to make them self dependent.
- (m) To render assistance and/ or grant aid to recognized public charitable or religious trusts, societies or institutions.
- (n) To do any other act for the advancement of general public utility, not involving the carrying on of any activity for profit, without distinction of caste, colour or creed.
3. For the furtherance of the objects of the Trust and in accordance with the provisions of the Income Tax Act for Investment or use of trust funds for the time being in force the trustees will have the following powers:-
- (a) To accept any donation, contribution, grant, fee or subscription in cash or in kind from any person firm, body or persons, body corporate or Trust or other institutions.
- (b) To charge tuition and other fees from the students and otherwise recoup themselves for the outlay and expenses incurred in the upkeep, maintenance and development of institution to be established by the Trust.
- (c) To apply or set apart the whole or part of the income of the trust fund or accumulation thereof or whole or part of the corpus of the trust fund for

any one or more of the objects of trust, as the Trustees may in the discretion from time to time determine.

- (d) To raise fund for the Trust for any capital and revenue expenditure and also borrow as secured loan or unsecured loan from any individual, bank or institution from time to time at the prevailing rate of interest and on such terms and conditions, not prejudicial to the interest of the Trust, as the Trustees deem fit and for raising such fund or loan they can sign, deliver, offer and mortgage and/ or hypothecate any immovable and/ or movable properties of the Trust.
- (e) To lend money at reasonable rate of interest, which is not prejudicial to the interest of the trust.
- (f) To purchase, acquire, take on rent or lease and develop properties for the Trust, from time to time and to convert and deal with the trust properties and/ or carry the investment for the time being.
- (g) To let out, sell, dispose of, alienate or otherwise deal with any property movable or immovable comprising the trust fund.
- (h) To adjust, settle, compromise, compound refers to arbitration all actions, suits, claims, demands and proceedings regarding the Trust fund.
- (i) To appoint Constituted Attorneys or Agents and to delegate to such Attorneys or Agents all or any of the Power vested in them under these presents and from time to time remove such Attorneys or Agents and to appoint other in his or their place.
- (j) To make, vary, alter or modify scheme, rules and regulation for carrying out, that object of the Trust and for the Management of the affairs thereof and of running any institutions, furtherance of the objects of the trust and otherwise for giving effect to the objects of Trust.



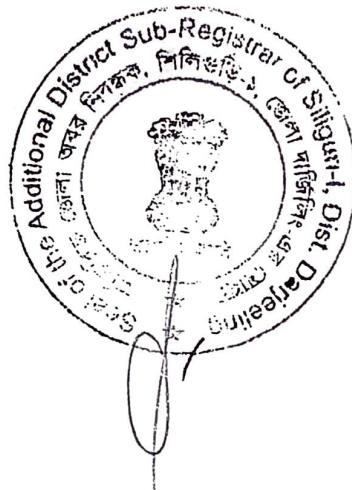

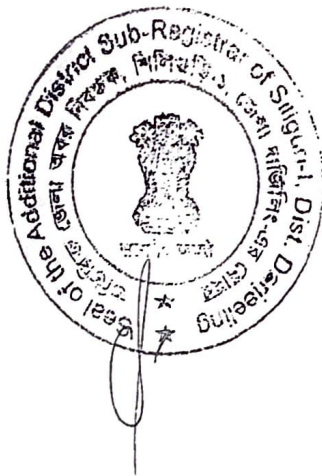

- (k) To set apart the whole or part of the income or the corpus of the trust for any of the objects of the Trust.
- (l) To open bank accounts in the name of the trust, which should be operated at any time only under the joint signature of any two of the following trustees, viz. (i) Chairman, (ii) Secretary, (iii) Treasurer, or their authorized attorney.
4. The Trustees shall cause true and accurate accounts to be kept of all money received and of all matters in respect thereof in course of management of Trust Properties or in relation to carrying out of all objects and purposes of the trust hereby created as well as of all assets, credits and effects of the Trust Properties. The statement of Affairs and Income and Expenditure Account shall be drawn by the Trustees at the end of 31st day of March each year according to English Calendar and the Accounting period will be from 1st April to 31st March each year.
5. In exchange of the services rendered to the trust, the Trustees may, by a resolution of the trust, receive remuneration and reimbursement of all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
6. The number of Trustees shall not be less than two and more than nine.
7. The trustees for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and reappointment as the Trustees for the time being consider proper. The Trustees appointed by these presents will be for life. If any Trustee dies, retires, becomes unfit or incapable to act, the continuing or surviving Trustees or Trustee will be competent to appoint a trustee in place of the trustees so dying, retiring or becoming unfit or incapable to act, either for life or otherwise as aforesaid.

8. SMT. SONIA PRASAD will be designated as 'Chairman' or 'Managing Trustee', and shall continue to act as such during her life until she resigns and thereafter Managing Trustee shall be elected out of the Trustees. The Managing Trustee shall carry out the duties and function of the Trust in consultation with other Trustees. SRI RAJ KUMAR PRASAD will be designated as 'Secretary'.
9. The trustees may from time to time frame or amend rules for the conduct and regulation of the meeting of the Trustees. In the absence of such regulation:
- Two Trustees shall form a quorum for meeting of Trustees.
 - All matters will be decided by majority.
 - Resolutions passed without any meeting of the Trustees but circulation thereof and evidenced in writing under the hands of 2/3rd of the Trustees shall be as valid and effectual as resolution duly passed at a meeting of Trustees.

10. Rules & Regulations:

- The Annual General Meeting of the General Body shall be convened each year within a period of 6 (six) months from the closing of the Financial Year of the Trust by Board of Trustees on such date, time and place as determined by them. At such AGM the Audited Accounts of the Trust and the Annual report of the working of the Trust will be placed before the General Body and election of Trustees to fill in the vacancy in accordance with the provisions contained herein will also take place. The Quorum of the General Meeting shall be 2 (two) members or 20% of the total members as on the date of meeting, whichever is higher.

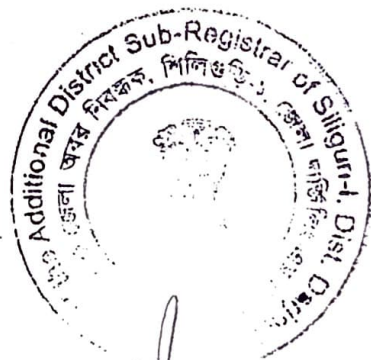

- ii) The trustees shall hold at least four meetings of the Board in a year at such place or places as the trustees may from time to time decide and shall regulate the procedure. The Quorum of the meeting of the board shall be 2 (two) trustees..
- iii) Any decision of the board shall be by a majority of vote and in the case of equality of votes the Chairman shall have the casting vote.
- iv) Before assuming office or taking part in any meeting, newly appointed Trustee shall give his consent in writing to act as such Trustee.
- v) All the meeting of the Board of Trustees will be presided by the Chairman or the Managing Trustee at his/ her discretion and shall upon a requisition in writing signed by any one or more of the Trustees specifying the objects for which the meeting is desired to be convened, call a meeting of the Trustees. If he/ she fails to hold such meeting within a month from the date of the service of such requisition the Trustees making such requisition may themselves convene a meeting of the Trustees but no business other than what is specified in the requisition shall be transacted at such meeting. In case there be no Managing Trustee, any of the Trustee shall be entitled to convene a meeting of the Trustees.
- vi) Notice of meeting of the Trustees and all other communications shall be sent to the Trustees at their respective addresses registered in the record of the Trust.
- vii) Any Trustee may delegate in writing all or any of his/ her power under these presents to his/ her nominee who will be entitled to act as long as such nomination remains in force to exercise such power or powers in the same manners as the trustee him/ herself could do personally.

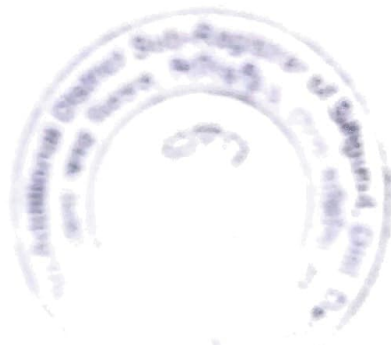

- viii) Every Trustee will be a liberty to resign on giving one month's prior notice of his/ her intention to do so.
- ix) The Board of Trustees may as necessary and from time to time appoint committees of Trustees and other members for such purpose as it may determine and may delegate to such committees necessary powers and functions. Any decision of such committees shall be by a majority of votes.
- x) A trustee shall be disqualified from continuing as a trustee or shall cease to be a trustee on the happening of any of the following events:
- (a) Death;
 - (b) Physical or mental infirmity;
 - (c) On being convicted in a court of law of an offence involving moral turpitude;
 - (d) On failure to attend without leave of absence four consecutive meetings or all the meetings in a continuous period of one year whichever is longer;
 - (e) On being adjudged insolvent;
 - (f) If he is requested to resign by 2/3rd majority or as near thereto as possible, of the remaining trustees;
 - (g) If he is found guilty of serious misconduct in relation to or concerning the trust estate or trust affairs.
- xi) The office of the trust shall be located at a place approved by the Board of Trustees and any change in location thereafter shall be

xii) DUTIES OF THE OFFICE BEARERS:-

(a) CHAIRMAN: (I) shall preside over all meetings of the Society; (II) Take all disciplinary actions such as removals, dismissals etc.; in consultation with the Governing Body; (III) Advise the Secretary in any matter requiring urgent attention; (VI) Call emergent meeting;

(b) SECRETARY:- (I) Shall convene all meetings of the society; (II) maintain minute books of all meetings; (III) issue general circular and notices; (IV) Receive all applications for membership which shall be placed before the governing body; (V) sign on behalf of the society all receipt for all sums received as subscriptions etc.; (VI) sign and give pay order on all bills for payment; (VII) Ensure compliance with statutory requirements; (VIII) Transact all other business subject to the direction of the governing body;

(c) TREASURER: (I) Shall collect and receive all sorts subscriptions, donations and deposits of money and grant receipts thereof; (II) Maintain and keep cash book and such other accounts; (III) Prepare the budget in consultation with the Secretary for consideration of the governing body;

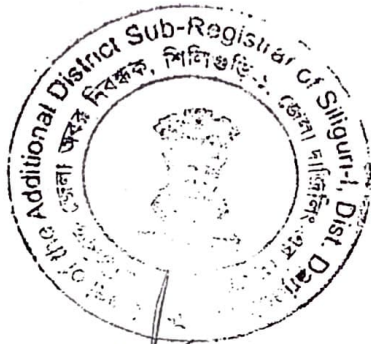
